As per clause no. 7 (Delivery Schedule) your firm was required to supply the material as per below mentioned amended delivery schedule:-

Firms has to supply the material as per delivery schedule and complete the both order within 05 months i.e. 02.01.2018 but the firm failed to supply as per delivery schedule and supplied only 495 nos. & 297 out of 3000 nos. & 2000 nos. respectively till date. Due to this abnormal supply there is hue and cry in the field offices of JBVNL and the management of JBVNL has viewed it very seriously as you neither worked as per PO/NIT nor apprised the JBVNL. Thus it is quite evident that your firm has failed miserably to fulfill its contractual obligation under the said purchase order.

Accordingly, the facts & status was analysed by JBVNL and it has been decided to short close the purchase order no. 83 (S&P) dtd. 03.08.2017 (under ADP Head) & 84 (S&P) dtd. 03.08.2017 (DDUGJY Scheme) and forfeit the Bank Guarantee or amount deposited against said both POs. Also, your firm M/s Shree Sidhi Vinayak Pole Industries, Tola-Deoly, PS-Govindpur, Dhanbad is here by debarred for period of 01 (One) year (from the date of issuance of communication) in JBVNL.
